SIGNIFICANT ACCOUNTING POLICIES

- 1. The accounts are prepared -
 - (a) In accordance with historical cost convention on accrual basis.

- 6. The Society had received the following assets from NIIT Institute of Information Technology A society registered under the Societies Act, at NIL cost. The Society is using these Assets for its activities and no depreciation is charged as these being at NIL value.
 - -Computer, Computer Software and accessories
 - -Furniture and Fixtures
 - -Library Books
 - -Office Equipments
 - -Air conditioners
- Inventories at the end of the year comprises of courseware materials and other consumables. The inventories are valued at cost on FIFO basis.



- 8. Retirement Benefits: Gratuity / Leave encashment is charged to the profit and loss account in the year of Payment.
- 9. The Society deposits its contribution towards Employees Provident Fund with the Regional Provident Fund Commissioner, New Delhi.
